Definition

Information can be many things. It could be a name, or information about an activity or event, such as going to the beach. It could be sharing that an individual has a certain talent or job. It could also be sharing which clubs are being attended.

Photos and Videos

Only photos and videos that show the individual in a positive way will be shared. We will share photos and videos where individuals are doing something they enjoy or demonstrating something they should be proud of.

Sharing With The Public: Sometimes, we share things with the public, which can be seen by anyone in the world with an internet connection, such as on social media, over the radio or on our website. It is important to know that after something has been shared on the internet, even if it is deleted, it is still possible that someone can find the deleted information. Be certain you are okay with that information being public before you give consent to have information, images or videos shared on the internet.

Website: www.autismsupportlouth.com is the Autism Support Louth&Meath website where people come to learn about what we do, where we are located, and how to contact us. Other websites link to our website and anyone can view it at any time.

Social Media: On social media and websites, people can share updates through text, video and images. Nearly every day, Autism Support Louth&Meath shares photos and videos on our social media accounts to show people what happens at our various clubs, camps and workshops. Typically, these posts show people we support, staff or volunteers doing activities.

Autism Support Louth&Meath has accounts on Facebook, and Instagram. We may join others in the future. Each social media has its own rules about privacy.

Always assume that any information you share on social media can be seen and shared by others.

Advertisements & Promotion: To tell more people about Autism Support Louth & Meath, to find more staff, volunteers or donations and to grow our services to support more people, we sometimes advertise or do promotional activities.
